### **Purpose of the Role**

Deliver Occupational Therapy clinical services as a member of a multidisciplinary team to stakeholders/customers of Queensland Health within Gold Coast Hospital and Health Service (GCHHS). Provide clinical care within specific wards or clinics including assessment, treatment planning and discharge planning for patients

#### **About the Profession / Service**

Allied Health Professionals within Gold Coast Health have access to an additional Professional Capability Framework for Allied Health which complements the organisation-wide Core Capability Framework. The Professional Capability Framework details the professional capabilities for Allied Health positions, providing a common language and set of expectations across the professions, and acting as a developmental tool to support and inform discussions about professional skill development and career progression within Gold Coast Health. The Occupational Therapy service provides a variety of clinical practice across the emergency, acute, rehabilitation and outpatient areas of the Gold Coast University Hospital (Southport) and Robina Hospital. Occupational Therapists also work within multidisciplinary teams in Community Health, Community Rehabilitation, Transition Care Programme, Child Development Service, Home Care and Allied Health Service, Palliative Care and in project areas of Persistent Pain Service and GEMiTH.

Occupational Therapists work closely with other medical, nursing, technical, operational and allied health professionals; and with other health service providers from government and non-government organisations. The position is expected to respond to the needs of their identified target populations and provide Occupational Therapy services to the identified client caseload on a prioritised basis. Occupational Therapists work within a team environment in the provision of quality health services, to ensure quality care of patients/clients in all settings and/or safe discharge. A major focus will be assisting clients to maximise their health status by provision of assessment, intervention, health education and support services.

# **Key Duties and Accountabilities**

- Comply with the Code of Conduct for the Queensland Public Service and all policies and procedures.
- Comply with the <u>National Safety and Quality Health Service Standards</u> and the Gold Coast Health <u>Clinical</u> Governance Framework in all areas of your practice.
- Fulfill the responsibilities of this role in accordance with Queensland Public Service, the Gold Coast Hospital and Health Service (GCHHS) values.
- Deliver Occupational Therapy clinical services, including assessment, intervention and evaluation within the
  multidisciplinary team in accordance with prescribed professional and ethical standards, including evidence
  based practice.
- Undertake routine Occupational Therapy tasks commensurate with level of experience in accordance with wellestablished clinical and departmental protocols, and under clinical practice supervision.
- As experience builds, apply increasingly independent clinical judgement to more complex clinical decision making under the clinical practice supervision or professional guidance of a more senior clinician.
- Participate in quality and service improvement activities within the Occupational Therapy Department, and relevant research to continually improve patient/client care.
- Develop clinical practice knowledge and expertise through self-directed learning, active learning within the team, and by engaging in professional development activities.
- Work cooperatively and effectively in a professional manner with multidisciplinary team members, clients and families/carers to achieve a client centred approach.
- Participate in the identification, development and implementation of quality and service improvement activities that enhance the delivery of Occupational Therapy services within your clinical area.
- Provide clinical education and clinical practice supervision pertaining to routine tasks for students and less
  experienced staff with the support of senior clinical staff.
- Provide clinical practice and operational supervision to students
- May be required to conduct home and community visits.
- Report operationally and professionally to the Hospital and Health Service (HHS) Director of Occupational Therapy, via the Assistant Director or Senior Occupational Therapist in the relevant work area.
- May be required to work on rotation to other programmes within the HHS that provide an Occupational Therapy service. In this situation the position will report operationally to the manager of that service, and professionally to the HHS Director of Occupational Therapy.
- Follow policies, procedures and instructions relating to work health and safety that are relevant to the work being undertaken in order to ensure high quality and safe services in the workplace.
- Take reasonable care for your own health, safety and wellbeing and take reasonable care to ensure that your acts or omissions do not adversely affect the health, safety and wellbeing of others.

- Employees who are appointed to the GCHHS are accountable for information security, management and appropriate use, in accordance with legislation, standards, policies and procedures.
- Comply with reasonable instructions that are provided for the safety of you and others at the workplace.

### Mandatory Qualifications / Professional Registration / Other Requirements

- Proof of possession of a tertiary degree in Occupational Therapy from a recognised tertiary institution. Certified
  copies of relevant qualification and registration must be provided to the appropriate supervisor/manager, prior to
  the commencement of clinical duties.
- Appointment to this position requires proof of registration with the Occupational Therapist's National Registration Board through the Australian Health Practitioner Regulation Agency (AHPRA).
- It is a condition of employment for this role for the employee to be, and remain, vaccinated against the following vaccine preventable diseases during their employment (Health Employment Directive No. 01/16):
  - o measles, mumps, rubella (MMR)
  - o varicella (chicken pox)
  - o pertussis (whooping cough)
  - o hepatitis B
- It is a condition of employment in this role for new employees to GCHHS to undertake a tuberculosis screening, to identify if the tuberculosis vaccination may be required in accordance with the Queensland Health Protocol.
- This position requires the incumbent to operate a government vehicle and an appropriate licence endorsement to operate this type of vehicle is required.
- This position is required to work throughout the Gold Coast Hospital and Health Service.
- Must be available to take part in a roster across 7 days including on call.

#### How You Will Be Assessed

You will be assessed on your ability to demonstrate the following key capabilities, knowledge and experience. Within the context of the responsibilities described above under '**Key Duties and Accountabilities**', the ideal applicant will be someone who can demonstrate the following:

- [A routine level of knowledge, expertise and skill in Adult Physical Occupational Therapy service (Acute and Rehabilitation settings).
- Ability to participate in a single-discipline or multidisciplinary team under the clinical practice supervision of more senior practitioners
- Ability to apply established principles to routine Occupational Therapy clinical services including the ability to self-manage both clinical and non-clinical caseload requirements.
- Ability or ability to rapidly acquire the skills to provide guidance to less experienced staff members and education to students.
- Demonstrated ability to enact the specified core role capabilities outlined within this role description within your practice.
